**IMPORTANT INFORMATION REGARDING YOUR PRESIDENTIAL PRIMARY ELECTION BALLOT**

Dear Voter:

SUBJECT: Presidential Primary Ballot Options for Unaffiliated Voters

The Presidential Primary Election will be held on March 3, 2020. Candidates for both the Democratic and Republican parties have filed in Utah. You are receiving this letter because your voter registration record indicates you are an **unaffiliated** voter. As an unaffiliated voter, you will not automatically be mailed a ballot for the Presidential Primary Election. However, if you wish to participate in either the Democratic or Republican Presidential Primary Election, you can request a ballot by following this step.

- Fill out the form below and return it by mail in the **postage-paid envelope** provided or email an image of it to the County Clerk's Office. Please keep in mind the following when completing the form:
  - The Democratic Party does not require voters to affiliate with their party in order to participate in its primary election, but you may choose to affiliate with their party on the form. (**NOTE:** Your request for a Democratic ballot must arrive in the County Clerk's Office no later than February 25<sup>th</sup> for a ballot to be mailed to you. The February 3<sup>rd</sup> deadline applies **only if you want to affiliate** with a party.)
  - The Republican Party requires voters to affiliate with their party to participate in its primary election. By requesting a Republican ballot, you are also affiliating with their party. Your request for a Republican ballot must arrive in the County Clerk's Office no later than February 3<sup>rd</sup> for you to affiliate and be mailed a Republican ballot.
