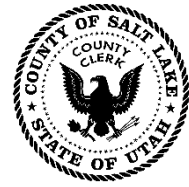

The Declaration of Candidacy filing period for justices and judges of a court of record begins Monday, July 1, 2024 and ends at 5:00 p.m., Monday, July 15, 2024.
