Citizenship Affidavit: I hereby swear and affirm, under penalties for voting fraud set forth in Utah Code Section 20A-2-401, that I am a citizen and that to the best of my knowledge and belief the information above is true and correct. *In accordance with section 20A-2-401, penalty for willfully causing, procuring, or allowing yourself to be registered to vote if you know you are not entitled to vote is up to one year in jail and a fine of up to \$2,500.*

Classification of Voter Records As Public Information *(How to restrict access to your voter information)*

9. Some information in voter registration records such as your name, address and the year of your birth has been classified as public information and would be made available to certain third parties, political parties, candidates for public office, their contractors, employees and volunteers in accordance with the requirements of Utah law. However, your driver license number, identification card number, social security number, email address and full date of birth are only available to government entities
- You may request that all information on your voter registration records be withheld from all persons other than government entities, political parties, candidates for public office, their contractors, employees and their volunteers.
- Yes, I request that my voter information be withheld from all persons other than government entities, political parties, candidates for public office, their contractors, employees and their volunteers.

Additional Privacy Protection

10. **Request for Additional Privacy Protection:** In addition to the protections above, you may request that all personal identifying information on your voter registration record be withheld from political candidates, their contractors, employees and volunteers by submitting a withholding request form because you are, or are likely to be, or reside with a person who is or is likely to be, a victim of domestic violence or dating violence.
- Also, a person who is, or resides with a person who is a law enforcement officer, a member of the armed forces, a public figure or protected by a protective order or a protection order may request additional privacy and protection of their records by submitting the request to the lieutenant governor or county clerk.

- A Utah Driver License, State ID card number or the last four digits of your social security number is required.
- Complete the form and return it to the County Clerk's Election Division at least **eleven** days prior to Election Day.
- Once you are registered, you will be mailed a Voter Information Card within two weeks. This is for your information and does not serve as ID.
- Salt Lake County elections are conducted mainly by mail. You will receive your vote-by-mail ballot approximately 3 weeks prior to each election pertaining to your precinct.
- Early voting and vote centers will also be available for voters who need to vote in person. Utah state law requires voters who vote in person to present identification.
