Welcome and Introductions

Approval of Minutes

CSG Project Update

- Jessy Tyler from CSG Justice Center reviewed the Salt Lake County's Key
 Criminal Justice and Behavioral Health Performance Measures (copy attached to
 original minutes). An overhead presentation followed which included the project
 timeline and an outline and in-depth analysis of the data included in the
 dashboard. The dashboard should be a high level monitoring system with key
 indicators alerting to both red flags and successes.
- Mayor McAdams said 2015 will be the year of the dashboard and data driven decisions for Salt Lake County. There is a need to determine next steps and desired outcomes so that goal setting can be implemented.
- Discussion followed with questions of linking other County dashboards, incorporating the dashboard into the CJAC Action Plan, and utilizing the data to add additional criteria such as homelessness, veteran status, etc.
- Mayor McAdams congratulated and thanked everyone for a great collaborative effort between stakeholders.

ECR Evaluation Final Report

- UCJC representatives gave an overhead presentation of the Evaluation of Early Case Resolution (ECR) Final Report (copy attached to original minutes).
- The study was conducted over a three year period.
- The overview of the study showed a sample selection of bookings based on numerous criteria and differences, comparing ECR and non ECR outcomes.
- Some of the study conclusions showed faster case processing but with gaps in service and higher recidivism.
- Discussion of the report outcomes, what is and isn't working, and what the next steps might be.
- The report will be reviewed by the Judicial Council the next week. David Litvack will attend the Judicial Council meeting.
- There are two sub-committees currently evaluating various aspects of ECR.
