**00:06 Welcome from Sheriff Rivera and Mayor Wilson**

The minutes from the November 2024 meeting were reviewed prior to the meeting. Judge McCullagh made a motion for the approval of the minutes, Kele Griffone seconded the motion, all were in favor.

The new chair rotation for 2025 was announced, Sheriff Rivera served as the chair for 2024 and passed the chair position over to Mayor Wilson.

**2:28 2025 CJAC Meeting Calendar Review and Update**

Historically CJAC has met bi-monthly on the even numbered months, with the December Meeting usually being moved to November due to holiday scheduling. The new proposed schedule would be moving CJAC to bi-monthly on the odd months. This would also allow for a scheduled pre and post legislative session review by the group. This would also make CJAC Leadership Meetings rescheduled to the even months.

Sim Gill made a motion to move CJAC to Odd months moving forward, Rich Mauro seconded the motion, all were in favor for the new schedule proposal.

**05:45 Workgroup**

Alex Allen reviewed the five current workgroups that are running to support initiatives of CJAC. These groups are meeting monthly and the question was raised what would be the best way to get the info up to the larger group.

Mayor Wilson requested a description, chairs, and meeting schedules for each group ready for next meeting.

**08:30 2025 CJAC Preview and Highlights Plan**

Alex Allen reviewed recent highlights from that have supported the work of CJAC.

-In December 2024 the Admin Office of CJAC (Office of Homelessness & Criminal Justice Reform) and Kenny Martinez with HMHI, presented on Civil Commitment and the handout created by CJAC staff to the Utah Commission on Criminal and Juvenile Justice (CCJJ) the State Body the Governs CJAC) to build up communication to the State.

-Also in December Anndrea Wild and Amber Lietz presented to the Sentencing Commission. They presented on the work being done through the CVIPI grant that the office manages

- Update on some new work happening in the CJAC workgroups and what to look out for in 2025.

**11:50 Regrouping Post Jail Receiving Center Bond**

Mayor Wilson informed the group that she will be meeting with the finance team as well as the SLCo Council to address ways of moving forward with the receiving center, Oxbow needs, and other jail system reform needs. Will be viewing this process as a long term and phased initiative as they work through the different barriers and ways to financially support the need.

**17:37 Bail Data**

Senator Stephanie Pitcher brought a data request to the group and Salt Lake County. There is upcoming legislation on bail and pretrial release. Senator Stephanie Pitcher pushed some legislation focusing on risk-based detention rather than wealth. She wanted to see if there was interest from the group in assisting with these data conversations around bail and pretrial release with new discussions and new legislation. Mayor Wilson said it seems like a reasonable request to submit data, but of course wanted to understand in detail what is needed.

Mayor Wilson recommended that Senator Pitcher submits an official request for the data. She mentioned that she would help facilitate this request and wants to ensure we have the right processes in place and understanding the Scope by bringing together a smaller group to start. More info will be brought back to the larger CJAC body post discussions.

**30:55 2025 Legislative Review- Behavioral Health Focused**

Tim Whalen presented on the legislative preview for bills focused on Behavior Health his office put together. He wanted to highlight some of the bills that may impact the work of the group and the system; reviewed by UBIC and USAFE.

This included Medicaid impacts, TAM Impacts, and impacts to County financial responsibility. The information will be shared with the group after for further review.

**51:11 2025 Legislative Preview**

Rich Mauro and Brett Robinson presented the 2025 Legislative preview for upcoming bills that may impact the work of CJAC, organizations in the group, and the Criminal Justice System. They reviewed current narratives that exist within the state and nationwide that may be influencing current bills. It was mentioned to remember the importance of referring to data and not just anecdotal stories when discussing policy changes. Pam Vickery also game some updates for Juvenile Justice related legislation.
